

Dear Ms Mayer,

in relation to the deliberations taking place over the future of Stoke Lodge playing fields, those of us living in close proximity to the space concerned (the last open space available to the public in Stoke Bishop) have been invited to cite the use which we have made of it over the years.

I have lived here since 1986. When we moved to the area my wife and I had three small children. As the years passed we frequently made use of the playing fields, both we ourselves and with our children's friends, to play football and cricket. Indeed, doing so, and thus obtaining regular enjoyment and exercise (and getting them away from television and computer screens), was a happy part of their growing up. We also often went for walks on the fields, like many local people. Altogether, the fields were a very important amenity.

As they remain. I now take my grandsons, who live nearby, up on to the fields for the same purposes as those which their father enjoyed. I hope to continue doing so with grandchildren who have yet to arrive!

I would say that the playing fields are a very important part of the life of the local community. It is good to see the use being made of them on Sundays by what appears to be a children's soccer league. Cricket teams play there as well, a pleasure to go and watch. Cricket teams do not play on The Downs.

Stoke Lodge Adult Education Centre is another, thriving, activity on-site. Hundreds (at least) attend courses there every week. My wife attends two language courses there. Its loss would be a body blow to the community.

I would be a serious and deplorable loss of local amenity if the fields were to be lost as well. For that reason I, and many of us, strongly support the Town Green application, if that is what it takes, to secure their future. It is very difficult indeed to understand Bristol City Council's muddled attitude on the subject, commissioning a report (at our expense) and then turning down the expert advice tendered!

#### Dear Sue

My husband Stephen and I live at 16 West Dene and have recently been made aware of fresh proposals to fence of Stoke Lodge playing fields to local people, except for the perimeter, and build artificial pitches for Cotham School. We are both horrified by this disclosure and the fact that no one official has alerted us to what is happening. I was told by my driving instructor who lives locally and belongs to a local facebook group. We value the field as an open green space, our garden is only about 50 meters away, and importantly chose the house to live in over twenty years ago for its pleasant location and outlook. We too regard it as the lungs of the local area and an important space to be enjoyed by everyone. "Improvements" such as the introduction of artificial pitches and floodlighting would have a terrible detrimental effect on the local environment, our lives and those of our neighbours. Since we have lived here there have been several new large housing developments nearby and Stoke Lodge is the only remaining local green space. We regularly use the whole of the playing field, especially at night to watch the local wildlife. The field is an important foraging area for foxes, badgers, hedgehogs and other species, and being able to watch the local wildlife gives us considerable enjoyment. In addition, there is a an important conservation issue that needs to be addressed. Changes to the habitat, fencing off areas and/or the introduction of lighting are likely to have a key impact on the local great crested newt population, a European protected species. My husband is sending you an email which addresses these issues and sending a copy to Bristol City Council.

Please let me know if you require any further information.

# Stoke Lodge parkland Conservation of the local great crested newt population

We are very concerned about the plans to develop Stoke Lodge, and the apparent lack of necessary documentation. The land in question is of high nature conservation value and an integral part of Bristol's urban greenspace. In addition to the considerable pleasure many people get watching the wildlife on the parkland, it supports an important population of great crested newts. Great crested newts breed in two of the three ponds in our garden, and we have been watching them egg-laying in our ponds this spring. If they are breeding in our ponds, there are likely to be other breeding ponds in the area. The ponds in our garden are within 50 metres of the Stoke Lodge playing field.

It is critical to consider the management of the land around great crested newt breeding ponds since the newts spend most of the year on land, and so appropriate management of the surrounding terrestrial habitat is of equal importance to the management of their breeding ponds. Great crested newts spend their lives within 200-500 metres of their breeding pond and it is generally recommended that areas up to 250 metres from the pond should be managed for great crested newts (see, for example, Jones & Sons Environmental Services Ltd 2007, *Harlow great crested newt 2006 survey report*). Development of a key part of their terrestrial habitat is likely to have a significant negative impact on this protected species, and this is of particular conservation concern since there are few populations of great crested newts within the built up parts of the city of Bristol.

Any proposals to introduce artificial lighting to this area, to fence off areas, or change the land use is likely to be particularly harmful to the conservation value of this parkland. European protected species such as great crested newts require studies prior to any application being made that could impact upon their habitat which is also

strictly protected by law. This normally takes the form of a range of surveys to determine population size and habitat use, and the preparation of a report with reference to the impacts of local destruction and effects on 'favourable conservation status' such that any proposal may, in an informed way, show how the proposal will overall benefit any species concerned.

At present the application has failed at this first hurdle. Indeed many planning authorities in England refuse to register applications until submitted with full environmental information. For European protected species, this should include a full Environmental Impact Assessment or at least a screening report at the first stage. These documents are conspicuous by their absence.

We are very concerned that proper procedures do not appear to have been followed and are copying this to Bristol City Council to seek their urgent reassurance that the Planning Department will require the correct information to be provided prior to considering any application to change the management of the parkland at Stoke Lodge.

We have instructed specialists to represent us on this matter and we will keep a record of costs incurred, should this be required at a later date.

I am writing in support of the TVG application in respect of Stoke Lodge.

I've lived in Stoke Bishop for seven years and my children have been babies, toddlers and now young children here. In that time, not having access to a large garden, Stoke Lodge has been a welcome nearby exercise ground for my two boys. They've learnt to play cricket, ride scooters and play tag rugby at Stoke Lodge. They have been to picnics and waterfights, both organised by the church and impromptu, there. My older son has played for local sports teams there while his toddler brother ran around the rest of the field with his friends (as a single parent, I had to keep him with me while we watched - unlike Coombe Dingle, where only the perimeter is available for spectators, the presence of the public field kept the little ones adequately entertained for hours).

We go up there at least once a week. The children use the playground but really it's the public open space that we love; being able to run races as fast and as far as they can manage, being able to kick a football as hard as possible, seeing how far a newly re-engineered frisbee can go without worrying about neighbour's fences or, indeed, heads.

Stoke Bishop is fortunate in being an affluent area, but not everybody who lives here has the benefit of a large private garden. Despite being in a green and leafy suburb, open space and parkland is scarce. For small and for growing boys with lots of energy to burn, having a green space at the top of the road to charge around in at will is immensely important. It's important for their mother's sanity, too.

The threat of losing Stoke Lodge has made me realise how important it really is to me. As well as the above, it provided a peaceful space for reflection, or a chance to bump into a friendly neighbour, at times when I really needed it. Bringing up kids on your own is hard; having open, accessible green space near you can only help, really.
