My wife and I with our son (then aged three and a half) moved to 95 Parrys Lane, Stoke Bishop on 27 November 1998. Ever since then we have been going across and round Stoke Lodge for walks, sometimes just the two of us but often with our son as he grew older.

From about the time he reached the age of five (in 2000) my son and I would often go to Stoke Lodge playing fields/parkland with a rugby ball or football, either after school in the summer or at the weekend in the winter, find a spot where we wouldn't bother anyone else, wherever that might be - anywhere in the grounds - and have fun for hours playing and practising and just having a nice time. And later when he became more interested in cricket we would go over there with a cricket bat and a tennis or cricket ball and do much the same thing, on many summer evenings after school (particularly in 2005 when England won the

Ashes!) In addition, I would often go for a run by myself through the grounds, particularly in the summer when a running track used to be marked out.

In the winter, if it had snowed, the three of us would go onto Stoke Lodge with our sledge to have fun or perhaps just to build a snowman. On such days there were often lots of families doing the same thing, and we would almost always meet friends of our son from Elmlea school to have an enjoyable time in this way.

On 27 May 2010 we moved to our present address 110 Shirehampton Road, Sea Mills which is almost as close to Stoke Lodge as our previous house, but from the other end, and so we carried on going to the Stoke Lodge playing fields. Our son is now a student in Nottingham but often in the Christmas or Easter or (especially) the summer holidays he will meet the same friends from Elmlea for a kick around of a rugby or football somewhere on Stoke Lodge (anywhere they can go so as not to interfere with someone else's enjoyment) and spend some time catching up with each other. My wife and I still often walk through and round the Stoke Lodge parkland for walks, especially on spring and summer evenings.

It would be awful to think of losing this amenity which we as a family have been using for more than seventeen years and where we have had so much pleasure down the years.

I am writing in response to your request as detailed in the flyer sent round to local people.

I live at 110 Shirehampton Road, BS9 2DX, where I have lived with my family for almost six years. We frequently visit the green oasis of the Stoke Lodge playing field as it is very close to our house. We generally arrive through the lower entrance, at the top of Cheyne Road, where you have to climb over the huge oak log, if it is muddy, or walk round if the weather has been dry. I often meet a friend to go for walks there, and especially enjoy making tours of the perimeter, which we reckon to be about a mile all the way round. The trees are wonderful, especially in spring and summer, but also in winter, and I have beautiful photos of them covered in snow, the last time we had snow, about 2 or 3 winters ago. In Autumn there are lovely blackberries and sloes in the hedgerows, which we have fun picking. There is such a variety of trees, from oaks to beeches to chestnuts, to mulberry, plum, damson and elder. We were sad when the cedar of Lebanon had to be so radically reduced, while being delighted to see the emerging sculpture that is going on at the moment.

I love to see so many people use this wonderful amenity, especially in the summer, when people go in the evenings to meet their friends and kick a football, or play cricket or rounders.

Before living in Sea Mills, we lived at 95 Parry's Lane, BS9 1 AN, where we were for eleven years. Our son was only 3 when we moved there, and Stoke Lodge has always been a great place for him to get exercise and run off energy. We used to take him there with his friends or his older brothers. It has always given us enormous enjoyment, fresh air and exercise, and the view of Blaise Castle, from the lower field, is especially picturesque on the skyline. It would be awful to think that we could no longer enjoy this marvellous amenity that contributes so much to young and old, all year round, year on year.

I hope that you will receive many more messages from local people who feel as strongly as we do that Stoke Lodge is a wonderful asset to our neighbourhood, and it is really worth doing whatever is possible to keep it.

My name is John Moore of 120 Parrys Lane, Stoke Bishop, Bristol BS9 1BJ. I have lived in Parrys Lane since August 1985. I have been asked to recall to the best of my knowledge the use members of my family have made of the playing fields at Stoke Lodge.

I can clearly remember that in the run up to the Football World Cup in 1990 that my eldest son, Oliver Moore, began visiting the open space of Stoke Lodge for football kickabouts with his mates. This took place on schooldays in the early evenings and at the weekends any time of the day in good weather. The kickabouts continued with his friends from Elmlea Junior school up until he was 11 in 1993. This activity encouraged my younger son Timothy Moore to follow in his elder brothers footsteps from around 1992 at the age of 8 until he left Henbury School as an 18 year old in 2002.

Both Olly & Tim took footballs over to Stoke Lodge for impromptu games with their mates using jumpers for goalposts. Tim had one friend from Elmlea, Chris, who excelled at Rugby (he went on to play professionally for several years in France) I can recall many was the time that Chris called at our house for Tim to join him in a Rugby kickabout between 1992 and 2002. Chris was always accompanied by the family dog that was never on a lead but was often carrying a soggy tennis ball.

Many were the times when I had to go over to Stoke Lodge as dusk fell to request the boys to come back for supper etc. On hotter days one of the lads would come back home with a request for bottles of water to take over to Stoke Lodge.

The boys played cricket in the back garden when younger with a tennis ball but later from around 1995 Tim in particular but also Olly outgrew the garden and would take the cricket ball, stumps, pads & bats over to Stoke Lodge in the summer. If it was just 2 or 3 they would play up against the tractor shed building at the Parrys Lane end of the field. If more were involved and they could afford the luxury of a wicketkeeper then the stumps would be in the middle of the field. I even joined in on occasions.

When the boys went to University in 2000 and 2002 respectively such communal games were less frequent but both used the Stoke Lodge field for golf practice during the holiday breaks and a couple of irons and golf balls resided permanently just inside the front door in readiness. Tim would also run laps around the field to maintain fitness and train for the Bristol & Bath half marathons that he took part in for several years from around 2006. I have also used Stoke Lodge to indulge in guerrilla gardening since around 2000. We have a hazelnut tree in the garden and as a result suffered squirrels nesting in the loft. We also had plentiful hazelnut saplings springing up all over the garden. I used to uproot these and transplant them amongst the shrubs around the top edge of Stoke Lodge field under the mistaken idea that the squirrels would relocate to Stoke Lodge although very few seemed to take the hint.

In recent years I enjoyed sometimes watching the local cricket club playing on Saturday afternoons. Since retirement in 2012 I have strolled across the field down to the private road leading into the Blaise Castle Estate. I do hope that such community & family use of Stoke Lodge field will outlive me and beyond.

fields in support of maintaining access for everyone.

For me it's hard to contemplate this area without Stoke Lodge which I have used most days for about 20 years either with the children or walking the dog or simply to get away from the hoards and enjoy the peace and quiet, not to mention picking mushrooms, blackberries every autumn.

We go there daily to walk the dog, sometimes twice a day and throw the ball across the fields for him to chase. We also use other areas for with the dog, but there is nowhere else you can throw a ball that is walking distance from home in Rayleigh road. When the children were younger we would go there to pay ball, had birthday parties there and summer parties using the white lines put out by the college for running, rounders and cricket. My son learned to kick a ball over rugby posts in Stoke Lodge and it was a safe place for him and his friends to disappear to in their teenage years.

Now when I'm looking for peace and quiet it's the only outdoor place you can get away from people and sit in the sun. Blaise Castle is buzzing with people and dog walkers and there's nowhere to sit and enjoy the sunshine. I have sat and studied for my professional qualifications on Stoke Lodge fields - the large tree in the middle of the ground is a good place to do this.

Of course have been many mad moments with the dog in the longer grass chasing imaginary prey in the long grass. I would be devastated to lose such a haven which is an integral part of living in this area.
