I am writing to express my disappointment and anger at the objectors to Stoke Lodge's application for VillageGreen status and to express how vehemently I believe Stoke Lodge playing fields should be granted the TVG status to protect it and enable indemnity from future developement from the likes of Bristol University and Cotham High School who have vested finiacial interests and are not interested in how building work and removing the space from the residents would affect the community.

We are lucky in Stoke Bishop to have this green space and it is a valuable addition to our neighbourhood and one we should preserve. It is used recreationally and has been for many years certainly by my family. Below demonstrates some of the ways I believe it as been and continues to be used:

- My daughter in the late 1980s and 90s regularly enjoyed much time playing out in the fields with a family who lived on Shirehampton Road and whose garden backed onto the field directly. It was lovely to have this space and extension of the garden.
- Along with the other children my daughter learnt to ride a bicycle there as it was a safe area.
- We held children's parties on the field and used it to play rounders and Kwik Cricket.
- The local Brownie Packs (late 1980s/90s) from Stoke Bishop and Westbury often went to the fields to play sports. Six or so local packs used to hold their annual Sports Day type event on the playing fields.
- My daughter is a Brownie leader now and the Westbury pack still use the fields now to practice for Sport Day as it benefits from having the track marked out in the summer.
- Currently we go there to run as it is more pleasurable than running on the roads.

This is one family's experiences but I am sure we are not alone in having benefitted from having this amenity and taken pleasure in it.

Stoke Lodge is our nearest park and so it is the place we go to most often when we want to be outside. My family and I have used Stoke Lodge about once a week since 1991 for:

The fields have only occasional by footballers and badly maintained for facilities.
